- 1. Call to order: Meeting called to order at 9:31 by Marilyn in the absence of Sandra.
- 2. Determination of Quorum: 2 of 3 committee voting members were in attendance. Dave will vote in the absence of Sandra.
- 3. Proof of Notice of Meeting: Provided by CAC via email
- 4. Approval of Agenda. Agenda unanimously approved
- 5. Approval of Minutes Finance Committee minutes from November 18, 2024. Motion made by Marilyn and seconded by Russ to approve. The minutes were unanimously approved.
- 6. Unfinished Business
- a. Budget Discussion post November BOD meeting
 - 1) Changes to Draft 2025 Budget pursuant to November BOD meeting
- a) Transfer \$100,000 of excess funds from 2024 Operating Funds to 2024 Reserve Funds; Blake sees no issue
- b) Rollover remaining cash in 2024 Operating Funds to 2025 Operating Funds; Blake sees no issue
 - c) Member monthly HOA assessment fee remain unchanged at \$510/month.
- d) Marilyn motioned and Russ seconded to forward budget changes in above paragraphs 6.a.1)a), 6.a.1)b), and 6.a.1)c) to BOD for approval at December 23, 2024 meeting. Motion passed unanimously.
- e) Pat said a copy of the 2025 KWGC HOA Budget will be included in the 2nd Notice for the Annual Meeting on January 25, 2025. A digital version will also be available online at

- b. Update Reserve Funds
 - 1) Reserve Funds should be adjusted as addressed in above paragraph 6.a.1)a)
 - 2) Reserve Study
- a) Two bids were submitted to perform a Reserve Study (with site visit) for KWGC HOA. The bids were reviewed by the Finance Committee members.
- b) Global Solutions submitted a bid at a cost of \$3187. They submitted an updated Reserve Study (without site visit) in 2022. They performed the last Reserve Study (with site visit) in 2017.
- c) Reserve Study Institute submitted a bid at a cost of \$6500. Their services and reports are comparable to those of Global Solutions.
- d) Dave motioned and Russ seconded that we recommend Global Solutions to perform a Reserve Study (with site visit) for KWGC HOA in 2025 as soon as practical. The motion passed unanimously.

- b. BOD approves carrying over the excess cash in 2024 Operating Funds to 2025 Operating Funds as part of the starting cash balance.
- c. BOD approves unchanged \$510 member HOA monthly assessment.
- d. BOD approves Global Solutions as the vendor to perform the Reserve Study (with site visit) as soon as practical in 2025.
